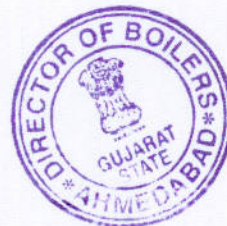

Sir,

With reference to above subject & letters you are permitted for **two years** to carry out manufacturing of **Stainless Steel seamless and welded Pipes , Tubes & U Tubes under IBR inspection subject** to the following conditions.

- 1) You are permitted to manufacture size range of seamless Pipes & Tubes up to 114.3mm O.D * 6mm thk., welded Pipes & Tubes up to 114.3mm O.D* 5mm thk. and U Tubes up to 50.8 mm O.D* 3mm thk. *Min. Radius 1.5D only
- 2) Drawings of U Tubes must be got approved from the undersigned before starting manufacturing
- 3) Mother tubes or pipes / Raw materials must be offered for inspection along with Mill test certificates in form IIIA or IIIB of IBR 1950 before commencement of manufacturing of pipes/ Tubes.
- 4) Tubes/Pipes must be offered for stage wise inspections as per Appendix-J of IBR-1950 to the Inspecting Officer of this Office.
- 5) Physical tests of finished tubes / Pipes must be done in the presence of the Inspecting Officer of this office in the laboratory of repute / approved by this Office
- 6) Chemical tests of finished tubes / Pipes must be done in the laboratory of repute/approved by this Office
- 7) Construction and workmanship must be in accordance the Indian Boiler Regulation 1950 and to the satisfaction of the Inspecting Officer and Inspecting Authority.
- 8) You shall have to carryout manufacturing of Pipes / Tubes as per instructions issued from time to time either by Inspecting Officer or Inspecting Authority.
- 9) This permission can be withdrawn at any time without giving notice if the workman ship is not found satisfactory as per IBR.
- 10) You will have to inform this office immediately if there is any change in existing name of the company/existing technical staff of the company.
- 11) You will have to employ sufficient technical staff to the satisfaction of the Inspecting Authority.



12) Renewal of this approval must be obtained from this office by applying atleast 60 days before the expiry of this approval.
